#### School Administration:

This notice reflects the actions of the December 8, 2020, Conference Realignment Task Force Committee Meeting regarding the realignment application that your school district submitted for consideration. Please note that the formal vote and rationale have been made public on the WIAA Conference Realignment webpage.

The Conference Realignment Task Force established rationale to evaluate the submitted 11-player realignment plans, and similarly developed potential alternate solutions.

#### Rationale:

- 1. Provide a conference for all member schools
  - a. Group by enrollment
  - b. Group by geography
- 2. Work to maintain paired 7-team conferences and 8-team conferences where reasonably able within geography and enrollment
  - a. 6 team double crossover also works
- 3. Competition within football groupings as rationale was not compelling at this time
- 4. Participation numbers and levels offered
- 5. Potential flexibility within forecasted regional shifts of co-ops and 8-player allow for future considerations

A school may appeal by having a representative appear at the WIAA office. Each school will be provided a maximum of five minutes to present new information to the Task Force.

All schools affected by a realignment solution may provide written feedback or appear in person on Wednesday, January 6, 2021. Each school appearing in person will be provided a maximum of three minutes to present new information to the Task Force. Schools in the same conference are asked to designate one spokesperson who will represent all schools. The time afforded to this spokesperson will be expanded to five minutes.

Hearings will begin at 10:00 a.m. A detailed schedule of appearances will be provided to schools following the January 4, 2021 deadline.

The Task Force will finalize and submit proposals for the March 5, 2021 Board of Control Meeting following the January 6, 2021 Conference Realignment Task Force Meeting.
