2. Our students are eligible only at the schools that are also WIAA members within the chartering authority of our school district. We are not allowed to co-op with school(s) outside our district.
3. Our enrollment will be added to each of the schools where our students are eligible to participate.
4. In multi-high school districts, charter school students are eligible at the school of residence only. WIAA transfer rules apply.
5. If we voluntarily withdraw from the Association, we may not renew for a period of four (4) years.
6. We are not entitled to any voting privileges.

We acknowledge and agree to abide by all the rules of the Association and will conduct our athletic program in accordance with the Constitution, Bylaws, Rules of Eligibility, and Season Regulations as well as the interpretations and decisions of the WIAA.
