## WIAA Winter Team Tournament Sportsmanship Awards Announced

**STEVENS POINT, Wis.** – The Wisconsin Interscholastic Athletic Association, in cooperation with Rural Insurance, has selected the team Sportsmanship Awards for the 2008 winter State Tournaments.

The winners of the prestigious award are Antigo in gymnastics, Ellsworth in team wrestling, Oostburg in girls basketball, Iola-Scandinavia in boys basketball, Superior in boys ice hockey and the Mosinee co-op in girls ice hockey.

Antigo receives the sportsmanship award presented in gymnastics for the second time. The Red Robins also received the recognition in 2005. They won their first-ever gymnastics championship by capturing the Division 2 crown at the State Tournament this season. The schools and communities receiving honorable mention include Southwestern/ Cuba City and Waukesha West/North/South.

Ellsworth receives its second Sportsmanship Award following its display of sportsmanship at the team wrestling tournament. The Panthers were also the co-recipients of the award in wrestling in 1999. They finished runner-up in Division 2 this year, following a 36-22

dual defeat to Lodi in the championship match. They advanced to the finals with a 33-28 victory over Luxemburg-Casco in the semifinals. Arrowhead, Clear Lake, Franklin, Kaukauna, Milton, Pewaukee, Random Lake and Tomah received honorable mention for the award.

Division 3 champion Oostburg topped the list of schools and communities qualifying for the award at the Girls State Basketball Tournament. It's the second sportsmanship commendation for the Dutch. They also received the honor in boys basketball in 1986. The Lady Dutch's following displayed outstanding sportsmanship and enthusiasm in their 57-28 semifinal victory over Amherst and in their 43-37 win over Markesan in the championship final. Schools and communities receiving honorable mention include Altoona, De Pere, Eleva-Strum, Marshfield, Monroe, Oak Creek and Sheboygan County Christian.

Iola-Scandinavia was selected to receive the sportsmanship award in boys basketball following its 53-50 victory

over Regis in the semifinals and its 70-51 loss to Aquinas in the Division 3 title championship game. It's the second WIAA/Rural Insurance Sportsmanship Award presented to the Thunderbirds. They also received the recognition in football in 2000. Dominican, Eau Claire North, Monroe, Oshkosh West, Plymouth and Randolph received honorable mention.

Superior was chosen as the winner of the boys hockey Sportsmanship Award for the fourth time and for the first time since receiving back-to-back awards in 1996 and 1997. The Spartans also won the award in hockey in 1992. This year, they edged University School 6-5 in overtime in the quarterfinals before losing to eventual champion Eau Claire Memorial, 4-2, in the semifinals. Eau Claire Memorial received honorable mention.

The Mosinee co-op won the State title and the Sportsmanship Award this winter in girls hockey. The co-op, which includes D.C. Everest, Wausau East and Wausau West, defeated the Fond du Lac co-op, 5-0, in the title game after defeating Northland Pines, 4-2, in the

semifinal. It's the first time the Mosinee co-op has won the award. Northland Pines and Chippewa Falls/McDonell Central was also given consideration for the award.

The WIAA/Rural Insurance Sportsmanship Award is presented to one school and community in each of the State team tournaments. The award winners are determined by the conduct and sportsmanship displayed by athletes, coaches, cheer and support groups, mascots, bands and spectators. Additional consideration is given for the effort of school administrators and chaperones to insure support for their teams are positive and that the highest ideals of sportsmanship are upheld. Award winners receive a plaque and banner in recognition of the honor. Schools receiving honorable mention are acknowledged with a certificate of recognition.

The selection process includes contributions and evaluations from contest officials, tournament management, police and security personnel, crowd control and ushers, WIAA staff members, area hotels and restaurants. +

## Mueller to Deliver Message at Scholar-Athlete Reception

Peggy Mueller will be the featured speaker at the 25th Annual WIAA Scholar Athlete Award Reception & Ceremony at the Westwood Conference Center in Wausau on May 4.

She has experienced the thrills and benefits athletics has to offer throughout her life as an athlete and as a coach.

Her diminutive stature doesn't reveal her intense, competitive nature that has been the catalyst to an accomplished career and a lifetime of achievement.

Born and raised in Canada, she excelled in speedskating, participating as a member of the Canadian Olympic team in the 500-, 1000-, 1500- and 3000-meter competitions at the 1960 Olympic games held in Squaw Valley, Calif.

She won 11 Saskatchewan provincial titles and seven Canadian championships during her stellar speedskating career. At the University of Saskatchewan, she competed in basketball and diving during her collegiate career from 1960-64. She was named captain and selected all-star in basketball in 1962-63 and was the Saskatchewan Senior champion in diving in 1961 and 1963.

After graduation from the University of Saskatchewan in 1964, she later en-

rolled in the Masters of Science program at the University of Wisconsin and graduated with a degree in physical education in 1972.

During her coaching career at Madison West High School,

Mueller led the Regents to two State championships in basketball in 1976 and 1982. In addition, she led her squads to six conference titles, 11 regional championships and five sectional crowns during her tenure as coach from 1975-96.

She guided the Madison West track and field team to five State championships and five conference titles to go along with three sectional titles and a pair of regional championships from 1972-82. Her tenure as girls volleyball coach from 1977 to 1993 produced 14 conference championships, 12 regional titles, seven sectional crowns and a runner-up finish at the State Championships in 1986. Remarkably, in her two seasons as girls golf coach in 1973-74, she

coached the Regents to State Championships in both seasons.

For her outstanding accomplishments and contributions to sports, Mueller has received many honors throughout her lifetime. Among the numerous recognitions, she has been inducted into several Halls and Walls of Fame including the Saskatoon Sports Hall of Fame in 1991, the Wisconsin High School Track & Field Coaches Association Hall of Fame in 1993, the University of Saskatchewan Athletics Wall of Fame in 1994, the Saskatchewan Sports Hall of Fame in 1994, the Madison Sports Hall of Fame in 1996 and the Wisconsin High School Basketball Coaches Association Hall of Fame in 1998.

Other honors included receiving the Evans Trophy as Nutana Collegiate's top graduating female in 1960, the City of Saskatoon Award of Merit in 1960 and the University of Saskatchewan "Spirit of Youth" Award in 1964, an accolade presented to the most outstanding woman student-athlete.

Currently, Mueller remains active in contributing her time and efforts to interscholastic athletics, serving as a team host with her husband, Greg, at WIAA State Tournaments. +

# Eligibility Questions & Answers

## Residence & Transfer

**Q.:** We have a student who spent her freshman and sophomore year in X and lived in that district. Her family moved to our district the summer after her sophomore year but open enrolled her back to her former school, X where she attended first semester of her junior year. Second semester of her junior year she transferred to our district where she resides. If I am interpreting the rules correctly, she will be eligible to participate in athletics in the fall of 2008. Please verify.

**A.:** If this student is presently a junior, she has transferred to you after her 4th consecutive semester following entry into grade 9. Her transfer to your school did NOT accompany and/or come about as a result of her parents complete/total move to your district. She has no past status as your student. As I understand this circumstance, I would determine her not eligible to practice or play for one calendar year – 365 days from date of enrollment as your student.

**Q.:** My child who is now a freshman lives

with her mother. She participates in a couple of sports. Because of mother’s work schedule, she is unable to supervise my daughter. Her mother works nights and weekend. We (dad and mother) have decided to move my daughter to my home where she will live with me (dad) and her step-mother. She will have more supervision in my home. My question is will she be able to compete in her upcoming 10th grade school year if only JV and then in varsity in her junior and senior year?

**A.:** If your daughter transferred at the end of the current school year (the end of her 9th grade) and began the next school year at either the public or a private school as a 10th grader now living with you, unless the sending school had reason to object - your daughter would be eligible without restriction at her new school.

**Q.:** One of our families is thinking about moving to another district, B. They currently have freshman and sophomore sons. If they move to B, but choose to enroll their kids back here in A next year through open enrollment, will their boys,

next year in 11th and 10th grades, be eligible to play varsity sports at a high school, even though their parents will be living in B?

**A.:** Answer's ‘yes.’ See Handbook, p. 32, ROE Art. II, Section 1A-9. Has the family already applied for open enrollment this past Feb? You know the deadline for next year has past.

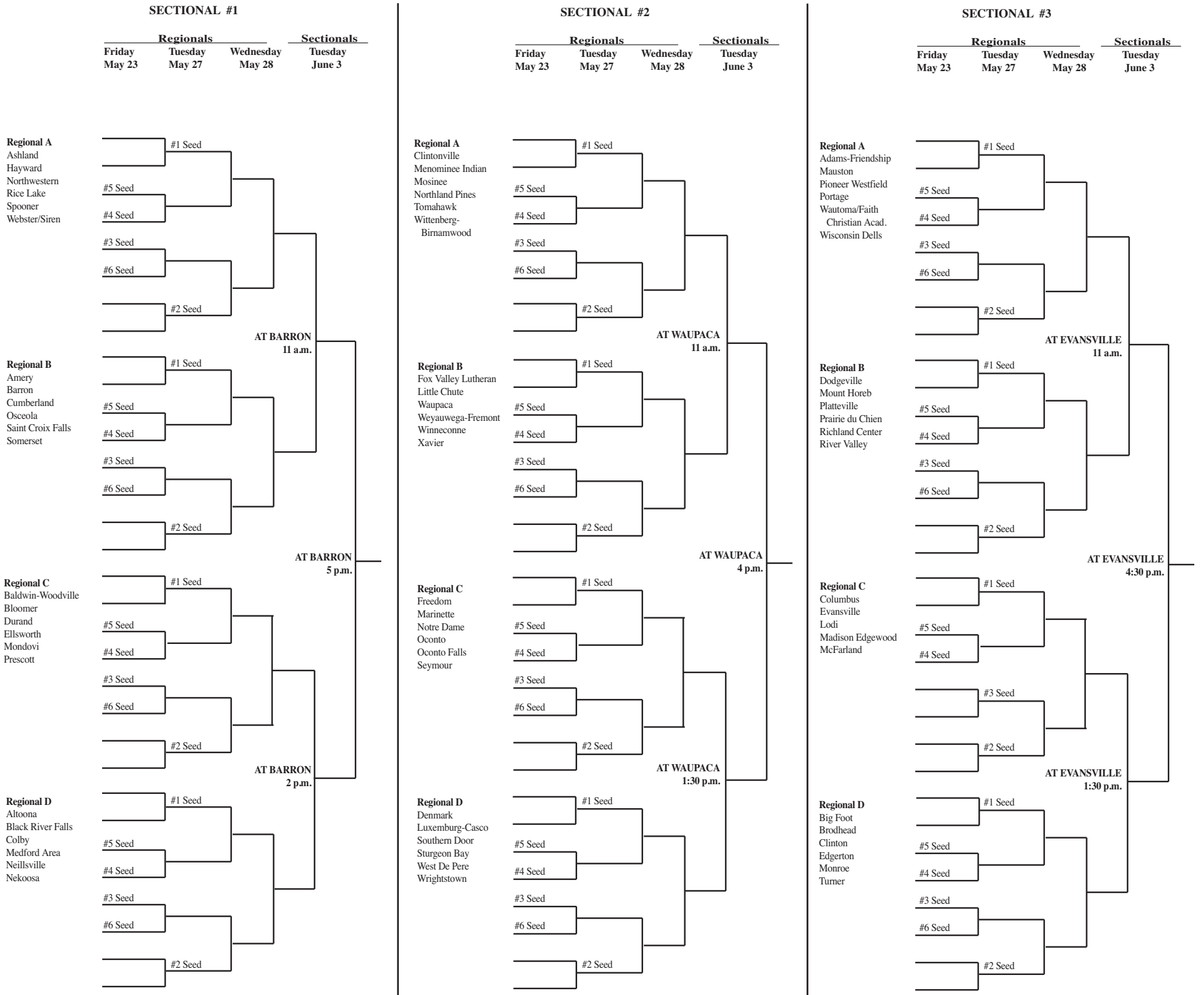
**Q.:** I have a student that is currently a sophomore at our school that has divorced parents. She is currently living with her father and step-mother here in X. She is considering going to Germany next school year to live with her mother and step-father (step dad is in the military). If she would do this and then decide to come back to X for her senior year would the transfer rule apply to her, namely not being eligible to compete or practice for one year?

**A.:** This one has a little subtle ‘twist.’ We will eventually need to know more and specific details if this materializes. What takes place in Germany may be of significance in

the final determination. But there is potential the student might have eligibility available upon return as a senior. Consider this scenario: If at the end of this school year (post 4th semester) student transferred to live with divorced parent in --- Madison e.g. Unless a waiver were provided we'd say she's ineligible to practice and play for next 365 days in Madison. And, that her unrestricted eligibility remained there at X. Same is essentially true if you said "Düsseldorf High" instead of Madison. So long as student does not re-establish her eligibility at/in another school, state, country – the only place she has eligibility is there at your school.

Amateur Status

Q.: I am getting the odd request for donations for raffles, silent auctions, etc., for signed stuff from the players, such as a signed t-shirt from the state champions. Is this a violation? I would like clarification.

A.: Kids signing a t-shirt. signing a stick etc., if YOU (the SCHOOL) wishes to make

such available - that is your prerogative. We do not presume such to be an endorsement or promotion in/of itself. It's names on a t-shirt. Watch out for requests to have team and/or athletes make personal appearances at such fund raising events/promotions - regardless the cause.

Q.: There are parents of middle/elementary students in our community that would like to pay a varsity basketball player to provide one-on-one instruction on a weekly basis this summer....any violation here?

A.: Yes. Violates amateur status provisions. Career ending. See Sr. High Handbook, p. 34, Rules of Eligibility, Art. IV, Section B. To paraphrase; a student can be employed - but not self-employed in sport skills instruction.

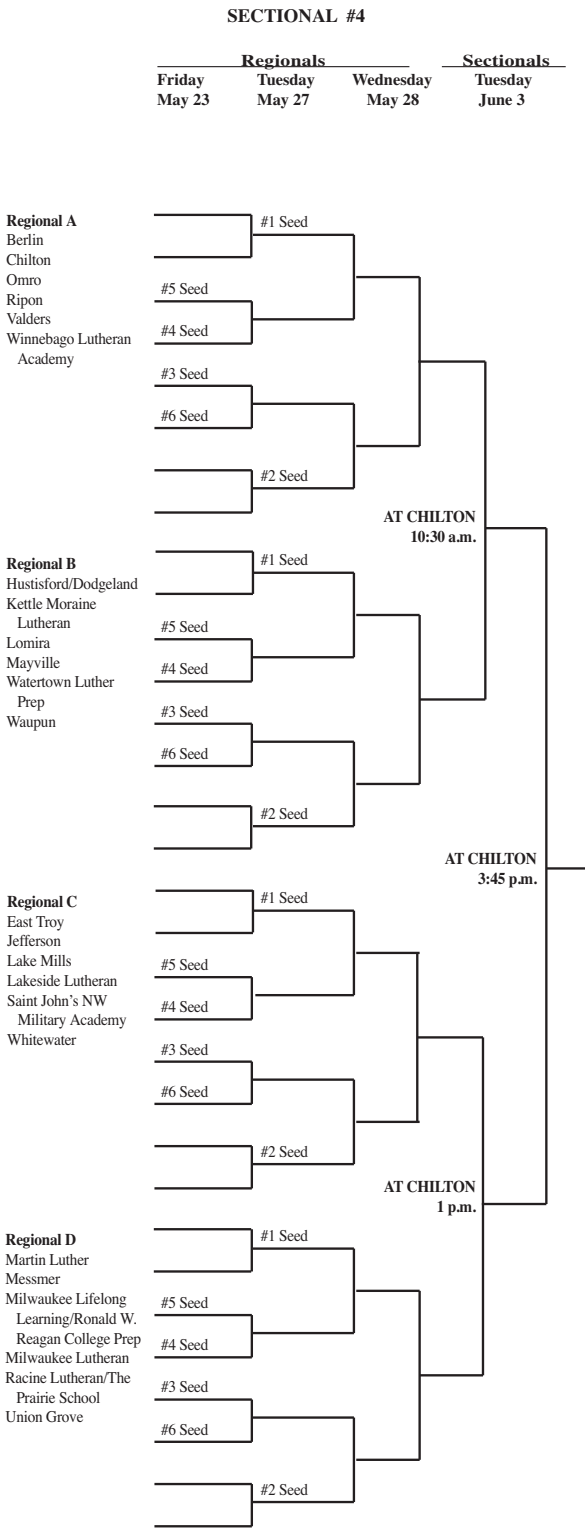
Participation Issues

Q.: I have a situation that I think is a no-brainer for the health, stability and well-being of our program, but, as you might imagine, a parent disagrees with my point of view. The situation is

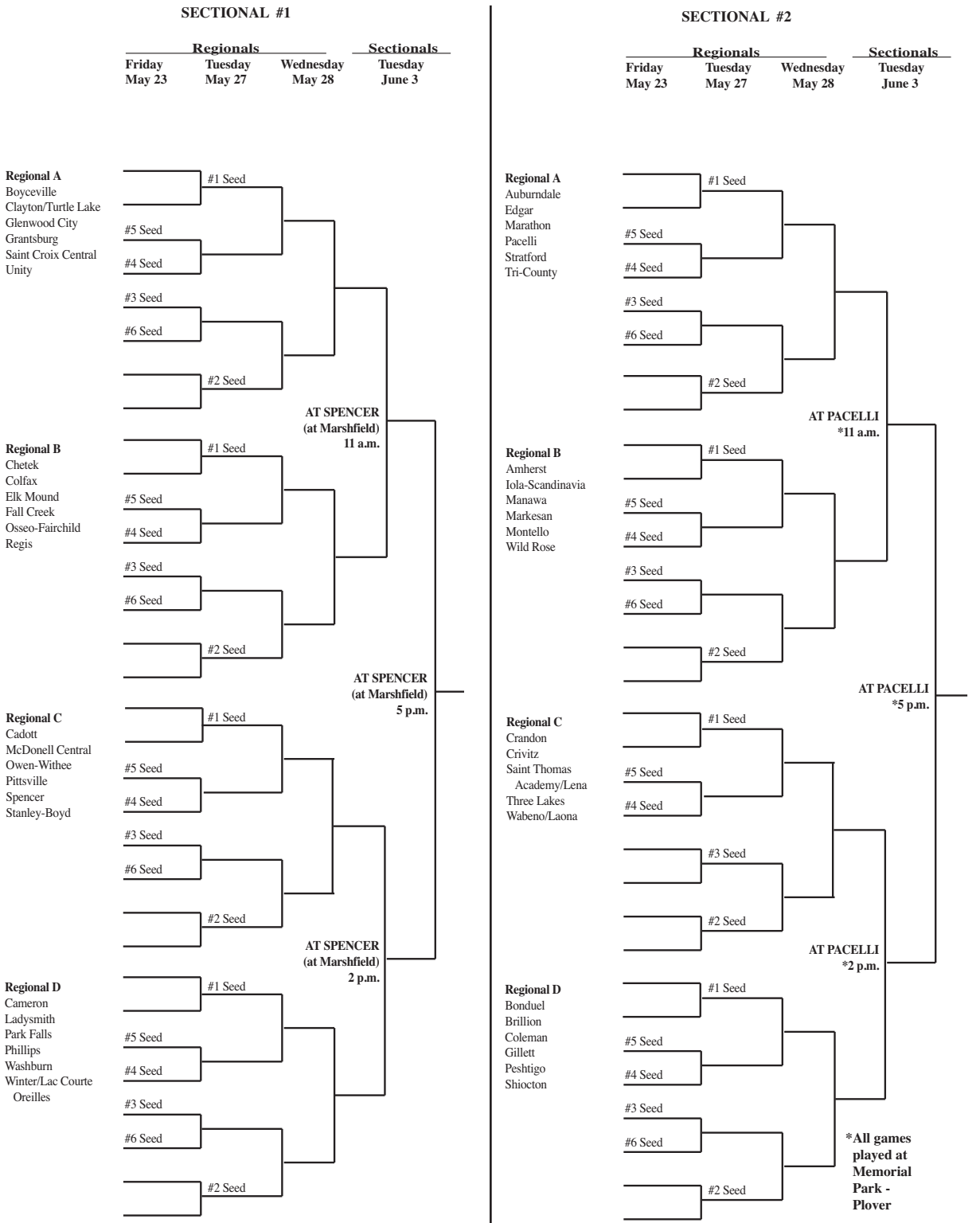
as follows: Student A wants to play baseball this spring and, to his credit, asked if it would be "OK to miss Tuesdays and Thursdays." He wants to play another sport on these days for a club team (hockey). My reaction was to say "no" and explained that the WIAA and baseball program have policies relating to and in place regarding this issue and pointed out the loyalty/allegiance issue involved. I then said, "I guess you'll have to make a choice." The WIAA policy that references this issue is: Article VI -- Nonschool Participation Section 1 -- In-Season A. "It is the philosophy of this Association that a student owes loyalty and allegiance to the school and team of which he/she is a member during the season of a given sport. A student becomes ineligible in a sport for the remainder of the season for competing in nonschool game, meet, or contest in the same sport during the season of practice and competition established by the school. The penalty may be reduced upon request of a school on the basis of documented extenuating circumstances." Could you

please respond and give your view on this? I think I've found a similar Q&A regarding this and am interpreting it properly. Nonetheless, what I feel you'll say is that it is NOT necessarily a violation of WIAA rules for Student A to play on this club hockey team during the WIAA spring baseball season, but a local issue. I, then, can interpret this rule and enforce our program policy as I have: That it would be unfair to other players and a detriment to our baseball program, setting a dangerous precedent, to allow such behavior.

**A.: You have accurately interpreted the member's rule in this area. Though the member's would not prohibit a student from playing club hockey during the spring ball season, the concerns you raise and more, from a coaches perspective, are not unreasonable.**

**Q.:** I have a question that I tried to research on your web page but did not find the answer. I have a step-son who has been playing hockey in a youth hockey league in a neighboring commu-

nity. He is going into high school next year, and the school district we live in does not provide hockey. My question is, can he play for the high school hockey team in the neighboring community without attending school there? He likes the school he is at and has many friends here, but he wants to continue playing hockey. So can he attend one school and play on a hockey team in another district without actually attending school there?

**A.: No – By their rules of eligibility, our member schools have agreed they can only use their own full-time students on their interscholastic teams.**

Coach Contact

**Q.:** I have a few questions about boys soccer contact days. It's my understanding that there are five unrestricted days allowed and that they must occur before August 1. I am now president of a soccer club and we would like to schedule a pre-season tournament on July 26 and 27 for

boys high soccer teams. We would like to promote it as an opportunity to use two contact days where schools would be able to play against other schools with the added benefit that teams could actually be coached by their own high school coaches. Teams would pay an entry fee. Is this legal? Would WIAA refs be required?

**A.: Correct. We typically publish it as – from end of school in spring – to no later then (by or before) July 31; making no mention of August. Bottom line, your dates work fine! Exactly as described - with all participating schools using two of their unrestricted contact days – ‘YES’ this would be in compliance with summer contact provisions. I think that given the risk of injury just days before the start of the school season using WIAA licensed sport officials would be far and away more attractive to our members. Why would you not want to use WIAA officials?**

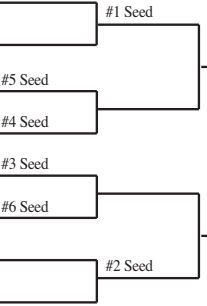

**Q.:** Two questions: 1. Football now has five unrestricted contact days is that correct? 2. A coach cannot hire a personal trainer for his or her players. Is that correct? Can a coach hire a personal trainer for his or her players but have the student athletes pay for the services?

**A.:** Yes, football coaches now have the same contact opportunity as other coaches in the summer. When it comes to camps, clinics specialized training/instruction – only student/family are able to cover 100 percent of costs. But, not certain I completely understand all the dimensions which may surround this question that would be needed in order to provide quality interpretation. In season – out-of-season? Boys, girls? Personal funds, booster money or activity account? Concerns are rooted in amateur status, gender equity. Remember, too, participation in out-of-season programs must be voluntary.

**Q.:** Two questions concerning team camps used for a coaches contact days. 1) If a team travels out of state, do the travel days count towards the five contact days? 2) Can teams fund

raise to pay for the travel expense to these team camps. Example is the need to pay for the rental of vans, can the players fund raise for that expense?

**A.:** YES to both questions – but remember, fund-raising efforts must be voluntary, and if the team camp is part of the five unrestricted days then school can pay for all/any students interested in attending a team camp (school might use fund-raised money, held in activity account). If school is not paying for all interested students and/or camp is outside of unrestricted days, then each student writes their own check for camp. **Q.:** I am a nurse practitioner and requesting clarification of the WIAA rules regarding athletic physicals. Under 1. Medical Examinations a. general requirements, it states that the card must be signed by a physician or advanced practice nurse

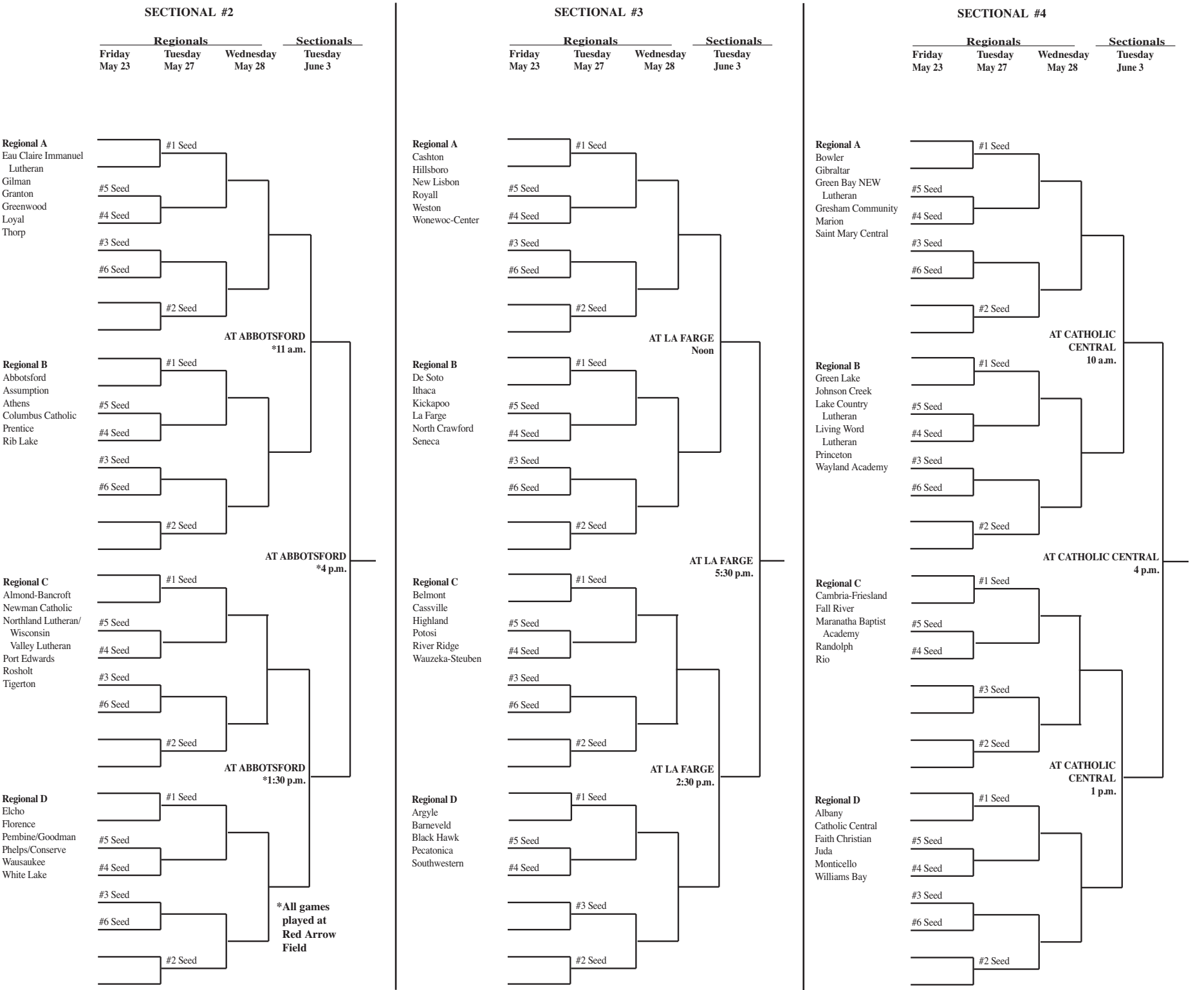
practitioner [prescriber]. Two paragraphs later it states that these exams can be done by physician assistants or nurse practitioner but this can be done only if verified by a physician. Physician assistants practice under the license of their supervising physician. Nurse practitioners are licensed to practice independently. Are we able to do these exams and sign these cards without verification or do they need to be stamped or co-signed? Please provide clarification on the rules for N.P.'s and P.A.'s as we have both in our clinic and will be starting these physicals very soon.

**A.:** That's correct, our member's current requirement states that exams can be done by physician assistants or nurse practitioner but must be verified by a physician. Our members have authorized only (and specifically) MD's and APNP's to independently perform and sign pre-participation exams. As it is written -- N.P.'s and P.A.'s might perform all or part of the physical examination but the card must be signed or stamped by the MD or the clinic he/she works for. Lastly, we have no text that identifies a nurse prac-

Our text specifically identifies APNP as advanced practice nurse prescriber. These two nursing credentials are different and are not one in the same.</div><div>Q.: Our code is an activities code and covers all activities including sports. If a student got a "Conduct unbecoming a student/athlete" code violation, according to WIAA, he/she would have to sit out one WIAA contest. Is that correct? If we apply our code and the next contest would be a forensics contest, that student would be required to sit out the forensics contest. Would he/she still be required to sit out one WIAA contest?</div><div>A.: Yes to both questions. The rules of eligibility specifically identify, a minimum of one/the next game, meet, event. The WIAA does not sponsor forensics. Our membership text does not address anything other the WIAA sponsored interscholastic athletic programming. ↵</div></div>



# Golf Interpretations

**QUESTION:** With the new WIAA coaching regulation, can a coach now walk down the fairways with their golfers?

**INTERPRETATION:** Yes, it is now allowable for a coach to walk down a fairway with a player. This can be done as long as play is not delayed in any way and the coach remains out of any bunkers and does not go on the greens during the meet.

**QUESTION:** Can a coach have an electronic measuring device and walk down the fairway with one of their players?

**INTERPRETATION:** Yes, walking down the fairway with a player and the coach possessing an electronic measuring device is allowed. It is players who are not allowed to possess electronic measuring devices. Coaches are allowed to do so

and are allowed to relay information to players.

**Spectators are allowed to carry and use electronic measuring devices, but may only relay yardage information to coaches. Spectators are not allowed to provide any type of information to players during a competition.**

**QUESTION:** Can a coach provide yardage (distance) information to an opponent?

**INTERPRETATION:** Yes, USGA definitions of advice have been modified to allow the exchange of information on distance, as it is not considered to be "advice."

**QUESTION:** Can a coach holler to a player on the green the break of a putt?

**INTERPRETATION:** Yes, a coach can holler to a player the break of a putt; however, appropriate golf etiquette needs to be

maintained so as other players are not disturbed and appropriate pace of play is maintained.

**QUESTION:** I am concerned about the pace of play we may be dealing with this year due to the new WIAA coaching rule. Can you explain how pace of play delays should be handled?

**INTERPRETATION:** Keep in mind that pace of play requires both a time limitation and a continuous flow where a group of players get more than a hole behind the group in front of them.

**WIAA Spring Season Regulations, Boys Golf, page 15, 15., g., indicates, "Host schools must determine an appropriate length of time to play the course. Each host manager must mark the starting time on a designated card for each group, with one card marked per group. The rec-**

**ommended amount of time is two hours and 15 minutes for nine holes and four hours and 30 minutes for 18 holes. First violation – a one-stroke penalty will be assessed to groups that do not meet the pace of play limits."** If a group is behind in time and more than a hole behind the group in front of them then the penalty for delay is a group penalty on the players in that group.

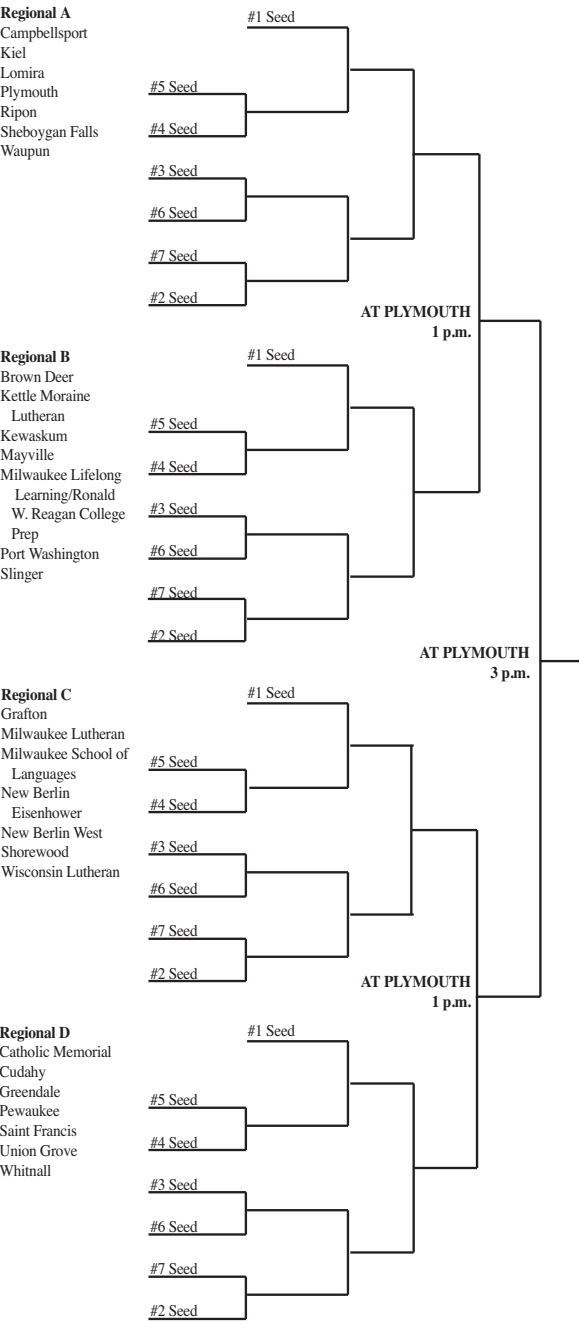

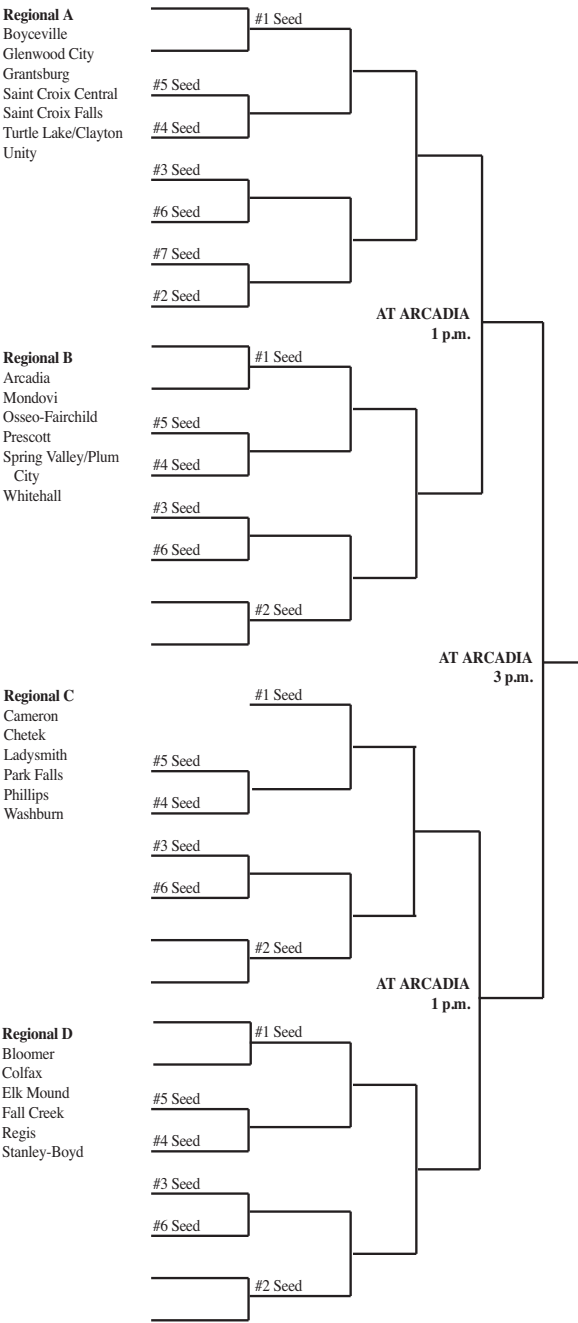

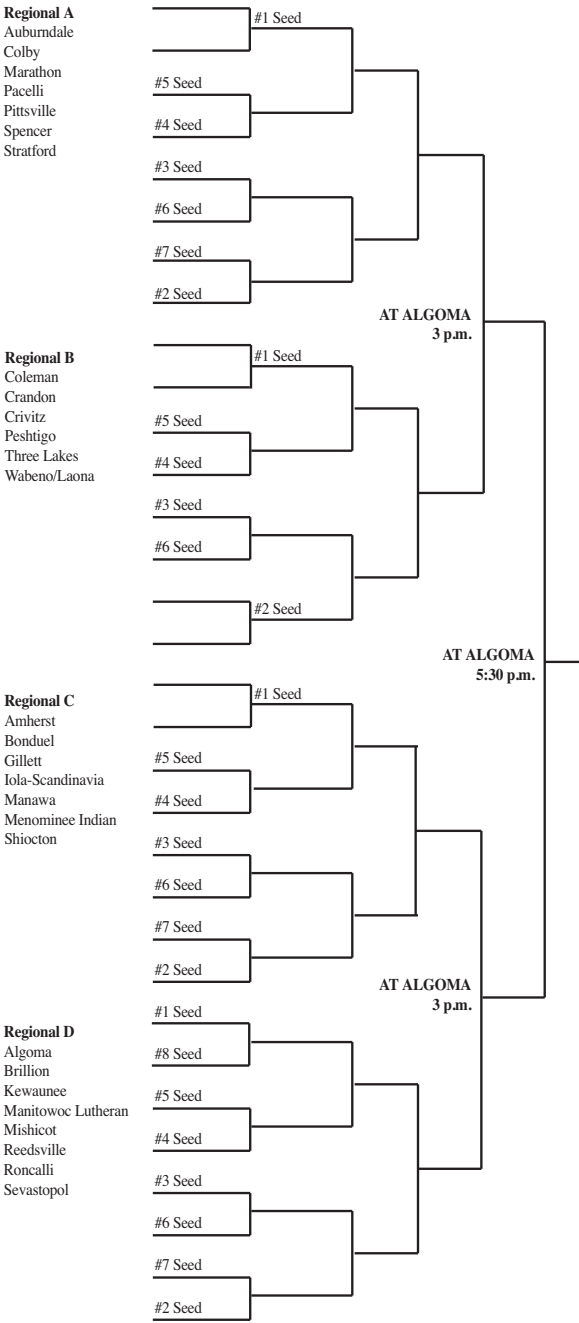

who have caused the delays: “If a player or players feel an individual or individuals are responsible for the group’s penalty/penalties under this structure and would like the meet management to consider waiving the penalty/penalties, the player or players must make an appeal to the meet director/tournament director or the senior rules official prior to leaving the scoring area.

**QUESTION:** I would like to take my team to another course to practice (because our home course is not going to open too soon) - the issue is that this other course is not one of my “home” courses - we do not play a match or tournament at this course this year, so if I take the team over there, does that practice have to count as a meet (toward our maximum)?

**INTERPRETATION:** Yes, WIAA Season Regulations, page 14, 9.,

identifies that it is practice at courses where later in the season (regular season and WIAA tournament series) your team will be competing must count such practices in its maximum allowed meets. If you do not have a regular season meet or a WIAA tournament series meet at this site, you are allowed, with school administration approval, to practice at this site.

**QUESTION:** If a coach sees a player throw a club, they are supposed to report that to the tournament manager. Are they supposed to tell the player? Are they specifically not supposed to talk with the player? In most cases the coach is out on the golf course and will not see the tournament manager for some time and the player may not be notified until much later than the infraction. What if another player in the group wants to call the player for throwing a club, what is that procedure?

**INTERPRETATION:** If a coach sees a player throw a club, the correct procedure as described in 15., c., page 15 of the WIAA Season Regulations, identifies that this kind of unsportsmanlike conduct should be reported to the tournament manager. The tournament manager is the one to investigate. Coaches should find the tournament manager as quickly as possible so the matter can be investigated and resolved.

If a player witnesses unsportsmanlike conduct in his/her group, “players may also assess another player a warning for the first violation and 2 stroke penalty for the second unsportsmanlike conduct violation, but must report a third violation to the tournament manager for disqualification.” For the first and second violations,

players are to inform the responsible player of the unsportsmanlike conduct and then inform their coach or tournament manager of the incident whenever they come around to their group. On a third violation, a player needs to report this infraction to the tournament manager.

**QUESTION:** Can our golf course provide a free pass to members of our golf team for the remainder of the year?

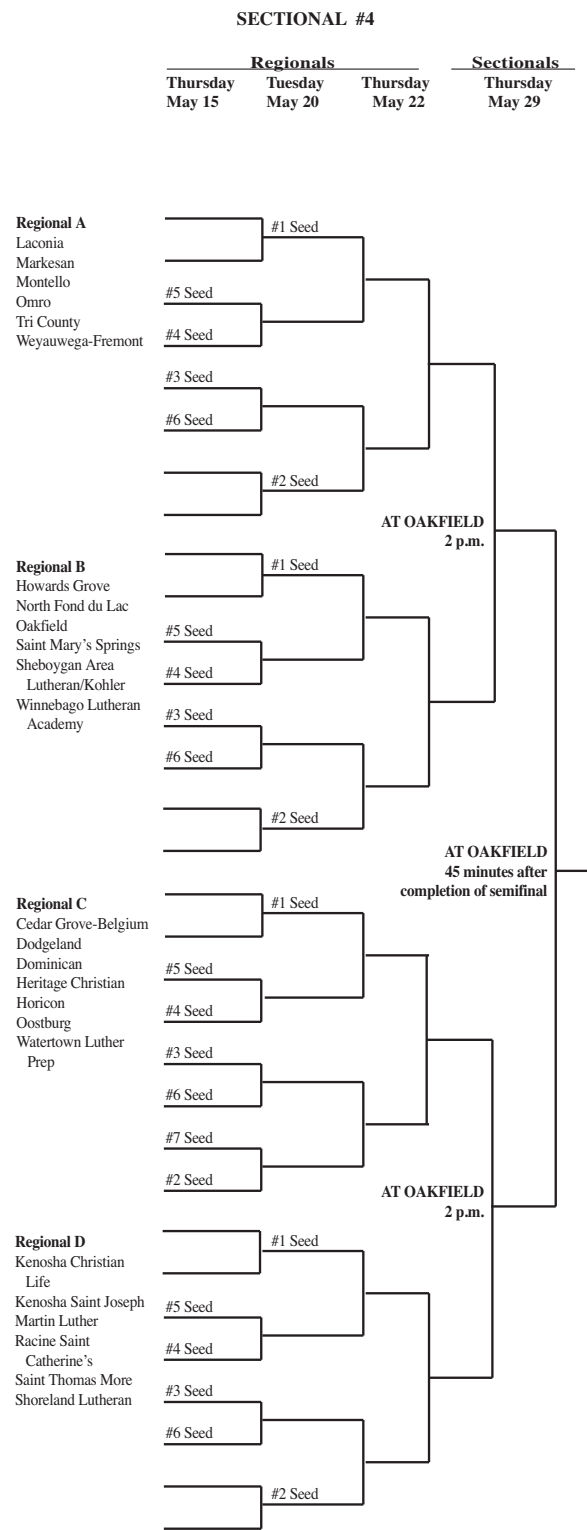
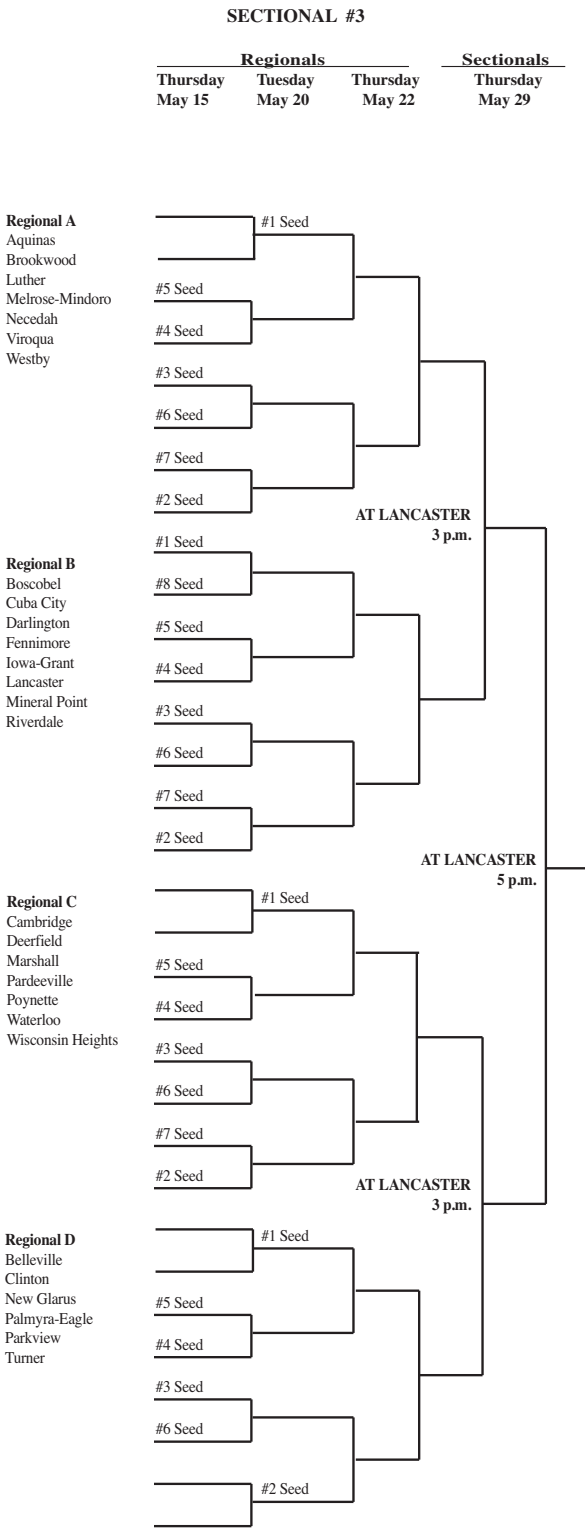
**INTERPRETATION:** Only if this offer of a free pass is not only made to the members of the golf team, but is also available to all students at your high school.

Providing a free pass to member or members of the golf team violates WIAA Amateur Status regulations where it is indicated: “A student shall be determined

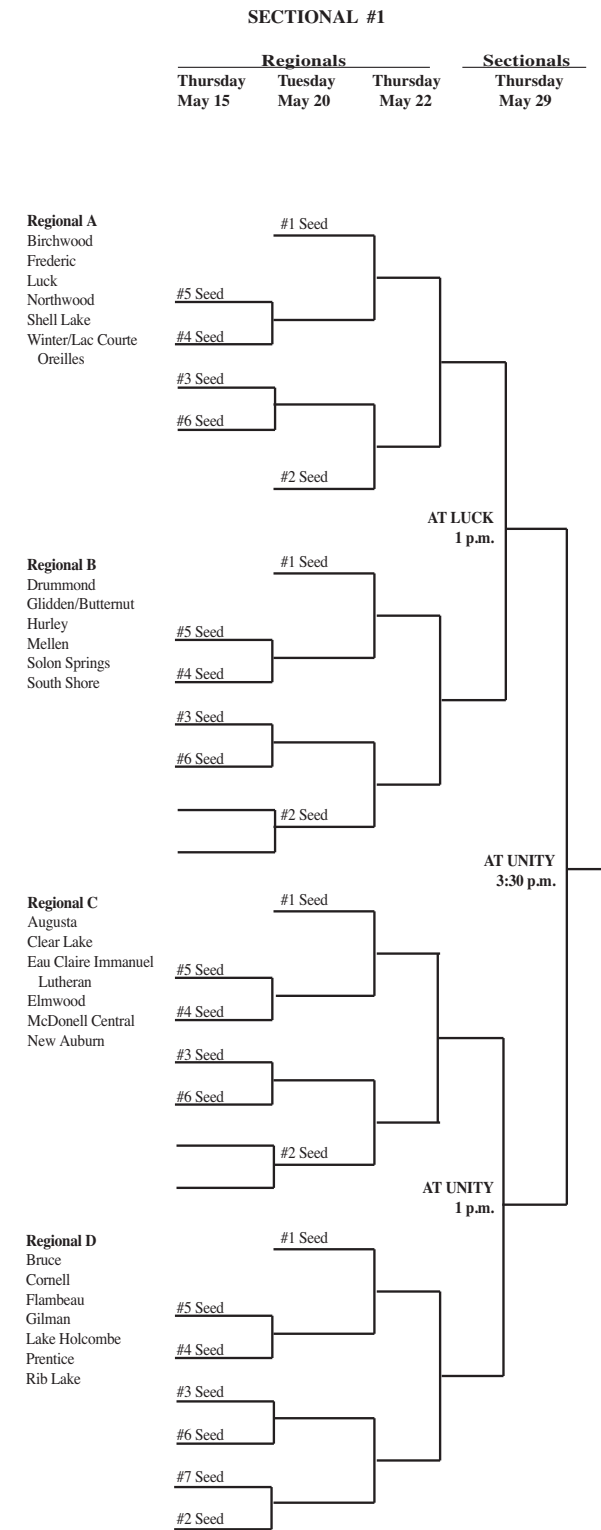

to be in violation if he/she: Accepts, receives and/or directs to another, reimbursement or award in any form of (a) salary, (b) cash, (c) merchandise of any kind or amount or (d) share of game or season proceeds, for achievement in athletics.

QUESTION: Can a school golf team be allowed to practice or compete at a golf course for free?

INTERPRETATION: Yes, so long as the golf program is open to all students in the high school to try out for the team, golf teams are allowed to receive benefits like free or reduced practice rounds, competition rounds, and range balls.

QUESTION: What if a golfer grounds the putter on the green, then the ball moves, and then the player takes his stance?

INTERPRETATION: USGA Decision 18-2b/4—If the ball moved after the club was placed in position but before the player had completed taking the stance, he

incurs a penalty stroke under Rule 18-2a for having caused the ball to move and must replace the ball, unless there is strong evidence that wind or some other agency caused the ball to move.

QUESTION: Can high school golfers participate in any of the WSGA Match Play Qualifiers, May 21, 23 or 25, 2008?

INTERPRETATION: No, WIAA regulations as found in Article VI—Nonschool Participation on page 37 of the WIAA Senior High School Handbook indicate that events must be for international competition, National Federation recognized or on a level in golf with Walker Cup matches. Unfortunately, this event is a state-wide qualifier that is held during the WIAA school season. High school golfers that participate in this event are not allowed to continue competition with their high school golf team for the remainder of this year. In other words, should you decide to par-

ticipate in this event, you would not be eligible to continue participation with your school golf team during the WIAA tournament series. If you happen to be exempt from the qualifier, the actual match play competition does follow the WIAA State Championship Meet. Consequently, those high school golfers who do not have to qualify for this match play event, can participate in the June competition.

QUESTION: Is there a penalty stroke if a player takes a practice swing in a lateral hazard and barely touches the tops of the grass?

INTERPRETATION: USGA Decision 13-4/4—No, provided the player did not improve his lie or test the condition of the hazard—see Note to Rule 13-4.

There is some gray area with this rule as “grounding” the club in the grass is a penalty stroke—see USGA Decision 18-2b/5.

QUESTION: Is there a rule that golf meets cannot be held if the

weather temperature is below 40 degrees?

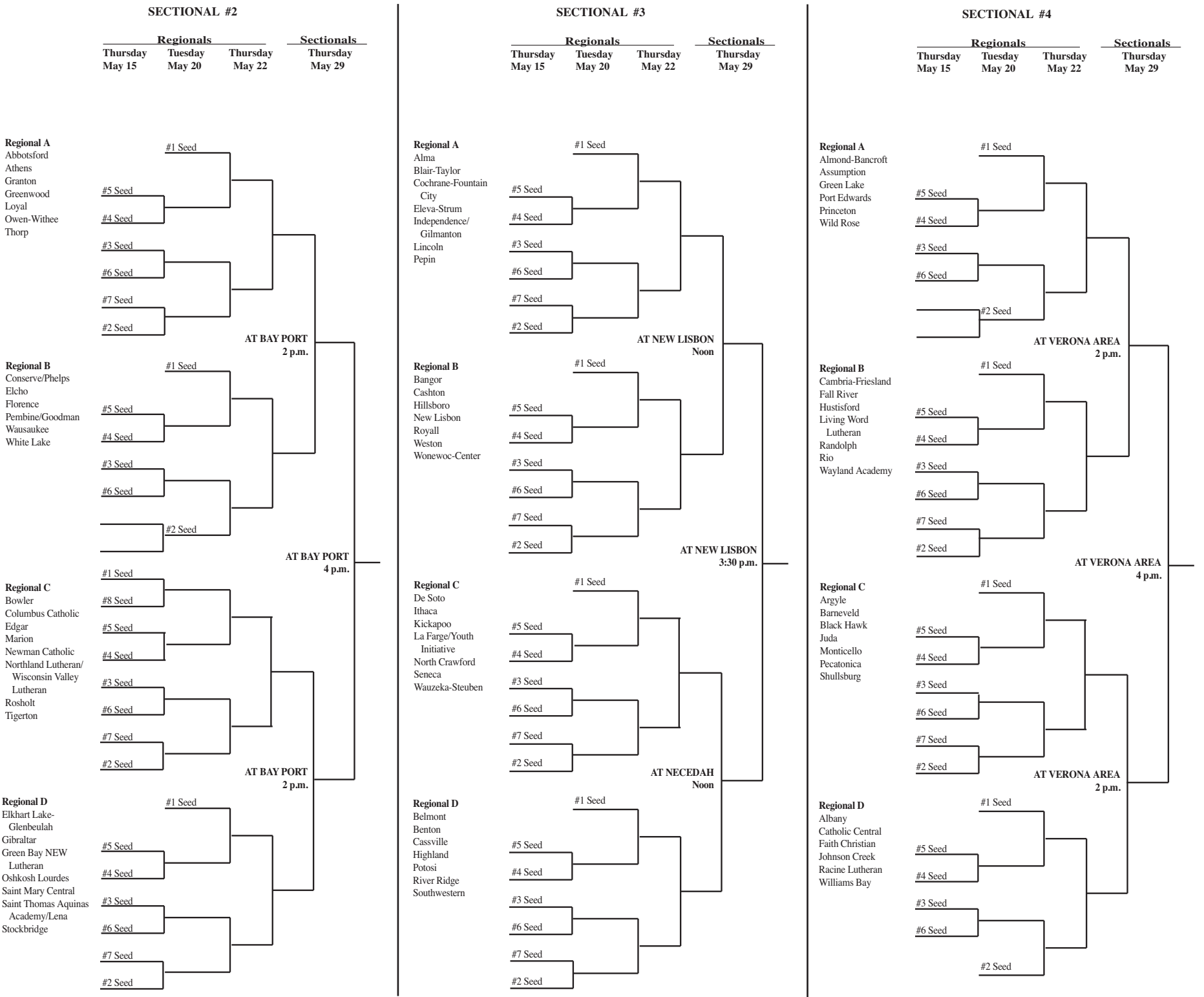
INTERPRETATION: The WIAA does not have any language that prohibits a golf meet from being held when the temperature drops to 40 degrees or below. Athletic directors and golf coaches should check with the host site management to identify if they have any such regulations.

QUESTION: Can we play both our varsity and JV’s in the same invitational on the same day?

INTERPRETATION: In golf, schools are allowed to play both their varsity and JV teams in the same invitational on the same day. Coaches and athletic administrators are advised to review carefully the MAXIMUM ALLOWED MEETS and the INDIVIDUAL PARTICIPATION LIMITATIONS sections of the WIAA Spring Season Regulations to be certain these maximums are not exceeded. +

# Tennis Interpretations

**QUESTION:** Will coaches have to type in all of our singles players' and doubles teams' wins and losses with the new on-line entry system?

**INTERPRETATION:** No, the entry system for subsectionals will be the same on-line system used this past fall for the WIAA girl's tournament series.

Added on to this entry system will be an area to identify WIAA State individual qualifiers and special qualifier requests. In this area, coaches will be asked to input wins over other singles players and doubles teams that are either qualifiers or are requesting special qualifier consideration. These are the only contests this new program will require coaches to input.

Coaches should continue to use the Individual Player Record Form we have used in past years and fax this to the WIAA by noon on Friday, May 23, 2008, if you have player or doubles team who has qualified for or is being considered as a special qualifier for the WIAA State Individual Tournament. The information contained on this document continues to be extremely helpful for the Coaches State Selection Committee.

**QUESTION:** In the tennis meeting video you refer to an electronic means of submitting a players record. Will there be a tool available that will allow us to electronically compile our players' stats during the season?

**INTERPRETATION:** I have looked at this carefully during the past month and have determined we will not be providing this electronic Player Record Form for coaches this spring. It is simply too much for coaches to currently take on.

Please continue to use the current Season Individual Record Form found on the WIAA School Center Website.

**QUESTION:** If a player withdraws from a match during the regular season, how is that now handled?

**INTERPRETATION:** The new regulation reads as follows: If a player is unable to compete (withdraws, retires, defaults, walks over, or disqualifies herself/himself) on a match during the regular season then the player/team records a loss on the season record for that match. During WIAA tournament play, the player may not return to play that day. If match is in progress, the score shall stand, any additional sets not yet played will be scored 2-0; for a match not yet begun 2-0, 2-0.

**QUESTION:** We've come across situations where we go to a multi-team meet, and due to various reasons one or two teams might not be enough people to fill all 7 flights.

**INTERPRETATION:** If this is a confer-

ence meet, the conference needs to develop language as to how this should be handled and where the singles and doubles teams need to play. If it is a non-conference meet, the host school needs to determine how this will be handled. It has been suggested/recommended that if a school team does not have enough players to fill a team, they should be placed in rank order in the top positions (#1, #2, etc.) until all players are used.

**QUESTION:** At the same time, some teams have brought extra players who end up filling the vacant spots for a team other than theirs.

**INTERPRETATION:** No, WIAA Season Regulations, 6., c., A school may enter only one varsity meet per day. WIAA regulations do not allow additional players to take a vacated spot available from another team nor do WIAA regulations allow student-athletes from one school to practice with or compete for another school team other than the school where they are eligible.

**QUESTION:** The results of those matches are not recorded on their team's 'Season Record'.

**INTERPRETATION:** Results of all matches must be recorded and will be used for seeding purposes for the WIAA State tournament.

**QUESTION:** As long as the pace of play is not hindered JV coaches are allowed to talk/coach players. Is this correct?

**INTERPRETATION:** Yes, JV coaches are allowed to talk, coaches can provide signals to players. The intent of this rule is to allow coaches—especially head coaches—the opportunity to work with JV players who are learning the game of tennis during competitive matches. USTA Rule 29. Continuous Play and all other USTA and WIAA time limitations need to be maintained.

**QUESTION:** If a team is at a varsity invite with 3 or more sites, can a one coach be at each site?

**INTERPRETATION:** The new interpretation following discussion at the 2005 WIAA Coaches Advisory Committee meeting on this issue is that up to two coaches per level of program can provide instruction to tennis players as found in the WIAA Season Regulations at the times indicated. This allows two coaches to be identified at the varsity level and two different coaches (if available) to provide instruction at the JV level. Coaches must be under contract with the school as tennis coaches to be eligible to instruct during a tennis meet.

If the meet is a varsity only meet, only two coaches can be used to provide instruction.

**QUESTION:** Are JV and varsity coaches allowed coaching both levels at a meet?

**INTERPRETATION:** If a school has only two coaches (head coach and assistant), yes, both the head coach and the assistant can instruct both the varsity and the JV players during their matches. If a school has three or more coaches, the coaches that will be working with student athletes at each level need to be identified prior to the start of the match.

**QUESTION:** Can a school tennis team have their JV team compete in a varsity invite on the same day that school's varsity team hosts their own invitational?

**INTERPRETATION:** No, WIAA rules only allow one varsity meet per day per WIAA Season Regulations, 6., c., page 36.

**QUESTION:** Can a school tennis team have "captain's practices" prior to the start of the boy's tennis season?

**INTERPRETATION:** No, "captain's practices" can only be held during the summertime period. There are no restrictions relative to voluntary assembling of students during the summer in excess of five (5) days in tennis without school/coach involvement. (WIAA Sr. High Handbook-pg. 38)

**QUESTION:** Can scrimmages be scheduled for the varsity reserve and JV teams in tennis?

**INTERPRETATION:** Yes, however, a couple of points of emphasis here: 1. Please review the WIAA Season Regulations as found on page 35-36 regarding scrimmages. 2. Scrimmages are allowed so long as there is no loss of academic time. 3. An individual student is allowed to participate in only one day of scrimmage activity. Note: An individual student may participate in multiple levels of scrimmages conducted on the same day. 4. One tennis team cannot consider a scrimmage to be a meet and the other team to consider it to be a scrimmage. A scrimmage is either a meet for both schools or a scrimmage for both schools.

**QUESTION:** Can a singles player be entered at the number two position if he has played the varsity number three position most of the year and only played the varsity number two position twice?

**INTERPRETATION:** Yes, to be allowed to be entered in the WIAA Tennis Subsectional in singles flights 1, 2 and 3, a player must have played at least three singles matches during the regular season at any varsity flight. A player entered at flight 4 does not have to meet this requirement.

**QUESTION:** What would happen if the player in question play's #4 with his non-dominate hand throughout the regular sea-

son after which (after the conclusion of the regular season and before the start of the state tournament series) he has permission from his doctor to begin playing with his dominate hand. Let's say that playing with his dominate hand enables him to beat (in challenge matches) the player(s) on our team who played #1, #2 or #3 during the regular season. If that was the case and he was entered in the subsectionals as #4, would we be in violation of the 'order of strength rule'?

**INTERPRETATION:** Obviously, we can't predict this just yet and, ultimately, other coaches will police this matter. If someone is clearly better than the players above him, tennis regulations for rank order indicate that player must be moved up.

The answer if this happens is – yes – if a player is given approval to use his/her dominate hand after playing with a non-dominate hand throughout the regular season; if a coach believes he/she is the number one player on the team, during the tournament series he/she would have to be the number one player otherwise you would be in violation of the rank order regulation.

Coaches are going to question a #3 or #4 position when a player should/could be a #1. As always, I encourage regular documentation of challenge matches and regular season matches. In this case, since he was a State qualifier last year and almost won his first match against a very good opponent, it will be best to play him at the higher spot if there is any question.

**QUESTION:** Are the boys allowed to attend group tennis lessons during the season? These lessons do not interfere with or replace the school practice .... they are additional hitting opportunities for the players that are run by the club pro.

**INTERPRETATION:** After the conclusion of the school practice, student-athletes are not prohibited from attending other non-school practice sessions, clinics or instructional opportunities on their own. If this happens to be in a "group" scenario, they are allowed to do so. A couple of things to keep in mind with this, if the group tennis lesson is a requirement, then the instructor becomes a team coach, and this can only be done one time on one day. I also will always remind parents and student-athletes that ask this question that they do need to communicate their intentions with their head coach as risk of injury increases with additional workouts. In addition, differences in philosophy may exist between the school coach and the club pro; not to mention the loss of academic study time that is also being greatly reduced. +

# Track & Field Questions & Answers

NOTE: To lessen the impact of the new pole vault rule (7-5-29b) it is important to adhere to the time limit, 1 1/2 minutes (7-5-29e) to initiate an attempt. NFHS rules require that time limits for attempts be enforced in all field events (1 minute for HJ, LJ, TJ, shot and discus.) In the pole vault and high jump the time limits change when fewer competitors remain (7-2-5).

**Question 1:** Is it legal to run wearing a heart monitor?

**Answer:** Illegal unless the athlete is under the care of a physician. The physician's prescription must be sent to the WIAA and a waiver will be issued. Watches which are self-contained (no chest band) are legal. (Case Book 4-3-3, sit. D)

**Question 2:** Is it legal to have decals other than school issued or manufacturer's logos on a pole vault helmet?

**Answer:** The WIAA does not monitor decals on helmets. Unless the meet referee considers a decal offensive there is no restriction.

**Question 3:** Where are the pole vault weigh-in forms located? When is the second weigh-in period?

**Answer:** The forms are located on the main WIAA Track & Field webpage (not the School Center). Go to Rules & Regulations, listed under Field Event Information. The second weigh-in period started March 31. All

weigh-in forms must have this date or a date after the 31st. The final weigh-in will be May 12.

**Question 4:** Regarding the new pole vault rule (7-5-29b), where is the zero point located?

**Answer:** Rule 7-5-13; "The zero point is at the top of the back of the plant box." A failed attempt is charged any time the vaulter "...allows any part of his/her body or the pole to touch the ground or the landing system beyond the vertical plane of the top of the stopboard, without clearing the bar." (Rule 7-5-29d)

**Question 5:** We're interested in using a vendor for on-line entries for our meet. What options do we have?

**Answer:** There are three vendors with considerable experience: Direct Athletics (used for WIAA regionals) PTTiming [sean@pttiming.com](mailto:sean@pttiming.com) (Wisconsin based company) ASPI Solutions 515-292-2360

**Question 6:** If athletes are using Moyo blocks are they considered to be using a standing start and therefore subject to a two command start?

**Answer:** Incorrect. Athletes using Moyo blocks should be considered the same as athletes using traditional starting blocks. Three command start should be used.

**Question 7:** Are home-schooled athletes eligible to compete in our invitational?

**Answer:** Yes. At this time it is up to the host school whether they will allow home-school athletes to compete in their meets. Home-school students may not compete on a school sponsored team.

**Question 8:** Does the new pole vault rule which allows an athlete to leave the ground change the time limit rule when there is only one athlete remaining?

**Answer:** No. Rule 7-2-5 is applied as before; 6 minutes to initiate a jump.

**Question 9:** Are logos on headbands allowed?

**Answer:** Currently there is a distinction between headbands worn for warmth and those worn for hair control. The Track & Field Season Regulations, page 50 state "only headbands or knit caps which are unadorned except for school name, school nickname, or school mascots are legal". So if the headband is worn to keep the ears warm it would not be legal if it has a manufacturer's logo. The Track Coaches Advisory Committee will be reviewing this rule as it appears it may be somewhat outdated. Currently, if an athlete is wearing a headband for warmth and they have a logo, officials should have the athlete turn the headband inside out to hide the logo. Headbands worn for hair control or sweatbands are not subject to the logo rule. +

EDITORIAL

Annual Meeting Participation Cultivates Alliance with Membership

Whether it involves an election, a vote, different sides of a debate or contrasting opinions, the membership’s opportunity to express views and contribute to the rule-making process and the future course of our Association has been, and shall be, its strength.

Such involvement from the membership strengthens the Association and binds it to its purpose.

The democratic committee process and the membership’s directives determined at the Annual Meetings have served the Association well since the WIAA was established in 1896. Not all the outcomes were decided by a unanimous vote, nor did they all stand the test of time. However, changes over the years were ratified based on experiences, a perceived shift in culture and the desires of the membership.

For example, the original Constitution determined the start and end of seasons, which were later amended. And, it was decided at the 1923 Annual Meeting that “there should be no attempt to determine the state high school football championship and no team shall schedule games in order to determine such state championship.” Well, a little less than a century later, there is continued sentiment in modifying the starting and ending dates to seasons. Likewise, a half-century after the fact, the membership decided it was time to determine a football champion. In fact, since 1976, we’ve broadened our support to crown seven football champions.

Furthermore, a 1926 Annual Meeting amendment was expected to welcome the sponsorship of girls sports into the WIAA by an easy margin after it passed 169-22 in support to place it on the ballot. However, the amendment was defeated by the membership as reported at the Annual Meeting. Reasons given for not supporting the sponsorship of girls athletics are rather embarrassing when we look back with today’s perspective and experiences. It wasn’t until the 1970-71 school year that girls participated in a WIAA-sponsored tournament series.

In 1990, the membership defeated an amendment that would allow WISAA schools at the time to participate in WIAA tournaments if the former organization didn’t sponsor a respective sport by a 226-85 vote. In 1996, relatively the same amendment gained membership approval. Then in 1997, the membership voted 292-13 to establish a membership option for “non-public” schools.

Based on historical perspective, its astounding to see how we’ve progressed over the years and how the debates and pertinent issues of their time have been embraced or

have resurfaced over time. Regardless of the nature of those issues, the events of the Annual Meeting has been in the middle of them all.

Change is inevitable, and the Annual Meeting itself has changed over the years. Some may recall the Annual Meeting used to take place in the fall in conjunction with the Department of Public Instruction fall conferences. However, after the cancellation of that conference in 1970, the Annual Meeting went independent of those meetings and was moved to the spring in 1977. It remained that way after survey at the next Area Meetings revealed only nine votes for keeping the meeting in the fall.

This year ushers in another revision to the meeting. The open forum, which was originally conducted before the actual Annual Meeting agenda, then moved to the tail of the meeting, and now will be included within the meeting during the new business segment. Plans are also in place to make this year’s meeting the first to be streamed live over the internet. Schools and the general public can view the meeting as it unfolds on WIAA.tv.


While seemingly innocuous at first glance, this year’s proposed amendments to the By-laws and Rules of Eligibility will impact how the membership moves forward. One amendment would remove restrictions or the need for a WIAA waiver for schools to participate in approved regular-season events sponsored by a non-school provider if approval is given by school boards or governing bodies.

Another amendment requires schools to provide parents with the Associations Rules of Eligibility each year, requiring a signature to acknowledge they have received the information. This is an additional attempt to further familiarizing them to the membership’s eligibility requirements.

There are a number of editorial changes that will also need approval. These alterations don’t actually change the rules, but are intended to clarify existing interpretations of the rules.

Just as important as its impact on the Association’s rules is the Annual Meeting’s significance in advancing the synergy of common membership. Continuous accounts and the number of outside influences and self-interests placing schools and State Associations under siege is concerning.

By coming together to collectively make decisions, address concerns and plot the appropriate path for our future, we will remain a vibrant membership consisting of more than 500 high schools. +
