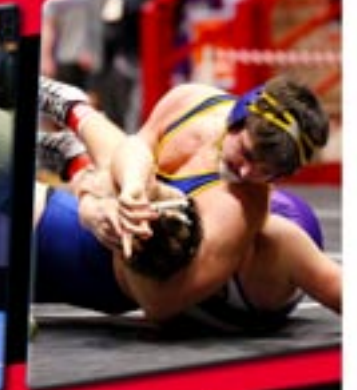

WIAA Provides Opportunities; Structure . . .

The Wisconsin Interscholastic Athletic Association (WIAA) is a voluntary, unincorporated, and nonprofit organization. The Association membership has a diversified membership of public high schools, nonpublic high schools, public middle schools, and nonpublic middle schools. Its purpose is to organize, develop, direct and provide interscholastic athletics for member schools.

There are 515 senior high schools affiliated with the WIAA. The estimated number of student-athletes in athletics is 80,000-85,000 annually.

Governance of the WIAA is performed by the member schools. Rules and policies of the Association are developed, promulgated and implemented by the membership either through membership vote for constitutional issues or through a membership-elected committee structure for sport seasons regulations. Therefore, ownership of the membership's rules and regulations, as well as the responsibility of compliance with them, lies with each member school.

The Development of Rules . . .

As fans watch the games during the tournament, some wonder how the rules of the game and of the WIAA were created.

- ◆ The National Federation of State High School Associations is the authority of the competition rules for sport contests (i.e. uniforms, length of contest, game rules). As a member of the NFHS, the WIAA adheres to those rules as a member in good standing. The WIAA, as well as all state associations in the NFHS, has input with an advisory role in the review and promulgation of the playing rules. The NFHS office is located in Indianapolis, Indiana.
- ◆ For changes to the membership's Constitution, Bylaws and Rules of Eligibility, a vote of the entire membership is required at the Annual Meeting each spring. The Constitution contains information relating to the Association as an organization. The Bylaws encompass information relating to member high schools' responsibility concerning WIAA rules and regulations. The Rules of Eligibility embody information relating to the relationship of the student-athlete to the high school and the WIAA.
- ◆ The Board of Control has the ultimate authority in determining the outcome of sport seasons rule recommendations and regulations. Changes to the sport seasons regulations are advanced through the democratic committee structure. Among the advisory groups that provide input to the Board are the coaches advisory committees for each sport; the sports advisory committee, comprised of school athletic directors from each of the seven districts; the Advisory Council, consisting of school administrators from each elector district; and the executive staff. Other groups with advisory responsibilities include the Medical Advisory Committee, Sportsmanship Committee and the Officials Advisory Committee. The Season Regulations address, among other topics, definition of the sports seasons, participation, contest control and tournament procedures.



Currently, the Association sponsors 24 sports including baseball, basketball, cross country, 8-player, 11-player football, golf, hockey, soccer, swimming & diving, tennis, track & field, volleyball and wrestling for boys; and basketball, cross country, golf, gymnastics, hockey, soccer, softball, swimming & diving, tennis, track & field and volleyball for girls.

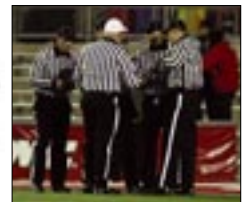
2021 State Preview

ABOUT THE DIVISION 1 FIELD: **Kaukauna** was issued the top seed in the bracket. The Galloping Ghosts qualify for the 12th time in the last 14 seasons and for the 19th time overall. They had a string of five straight appearances from 1999-2003 and have now surpassed that streak with their current run of nine consecutive appearances. They have won a total of four State championships, all coming in a row from 2014-17. The Galloping Ghosts have also finished runner-up four times, including 2000, 2003, 2008 and 2013. They qualified for State this year with a first-place finish at the Hartford Sectional. Three-time reigning champion **Stoughton** is the second seed. The Vikings are making their eighth straight appearance and their 15th overall. They have won 10 State team titles overall, including three since the advent of the team tournament format. Prior to the team tournament, the Vikings won seven State championships (1968, 1972, 1975-77, 1987-88). In addition, they have finished runner-up 10 times. This season, they continue their quest for a fourth consecutive title after finishing first in the sectional held at Mukwonago. Third-seeded **Holmen** is making its fifth straight appearance in the tournament field. The Vikings advance to the State for the 11th time overall. Their most notable achievement was a runner-up finish in 2018. Holmen qualifies this year after finishing runner-up at the Wausau East Sectional. **Waunakee** is the fourth seed after placing second at the Mukwonago Sectional. The Warriors will be making their debut in the State Team Tournament. Fifth-seeded **Marshfield** qualifies for the State Team Tournament for the fifth time overall and for the third time in the last four seasons. The Tigers advanced to the semifinals in 2002, 2003 and again in 2019, which represents their furthest advance in the tournament. They are the champions of the Wausau East Sectional. Sixth-seeded **Slinger** is making its fourth consecutive appearance in the team tournament, which also accounts for its overall total. The Owls are looking to advance past the quarterfinals for the first time. They finished second in the Hartford sectional to qualify this season. **Waterford** is the seventh seed, advancing to State for the third time. The Wolverines' first appearance, which came 24 years ago, resulted in a runner-up finish in Division 2. In their only other team tournament appearance in 2017, they fell in the quarterfinals. They were champions of the Brookfield East Sectional. **Brookfield East** returns after making the program's first-ever appearance at State last season, which resulted in a loss in the quarterfinals. The Spartans were issued the eighth seed for the second straight season. They earned another berth in the tourney field with a second-place finish in the sectional they hosted.

ABOUT THE DIVISION 2 FIELD: Top-seeded **Amery** will make its first appearance in the State Team Tournament. The Warriors earned their berth as champions of the Neillsville Sectional. **Prairie du Chien** was issued the second seed this year after the Blackhawks qualified for the first time in program history last season, which resulted in a loss in the semifinals. They are the champions of the Richland Center Sectional. Third-seeded **Winneconne** is also making its first appearance in the team tournament. The Wolves earned the berth with a first-place standing at the Seymour Sectional. Fourth-seeded **Kiel** returns to the team tournament for the first time in 20 years as the #4 seed. The Raiders first appearance resulted in a loss in the Division 2 semifinals in 2001. They advance this year by earning the title of the sectional hosted at Kiel.

ABOUT THE DIVISION 3 FIELD: Defending champion **Coleman** has been issued the #1 seed. The Cougars advance to State for the 15th time and for the second season in a row. They have won a total of 11 team championships. With the current dual format, they won the title in 2000, three in a row from 2010-12, in 2014, and again last year. They also claimed crowns before the dual format in 1960, 1962, 1963, 1964 and 1966 when there was only one division. In addition, they finished runner-up in 1959, 1961, 1981, 1983, 1996, 2008, 2013 and 2015. The Cougars are the champions of the Valders Sectional title to earn another State berth. Second-seeded **Mineral Point** returns to the field for the first time since a string of five straight appearances ended in 2011. This will be the Pointers' 11th team tournament overall. They have won 11 State championships overall, including five since the advent of the dual meet format. The Pointers won two straight Division 3 crowns from 2002-03 and three consecutive from 2007-09. They also claimed Class C crowns before the dual format in 1980, 1981, 1982, 1983, 1985 and 1986. They have also finished runner-up four times, including 1966, 1976, 2010 and 2011. This season, they are the champions of the sectional they hosted. Third-seeded **Random Lake** returns to the State Team Tournament for the 10th straight season and for the 12th time overall. The Rams' most notable experience in the tourney was a runner-up finish in 2009. They earned their berth with their finish atop the Dodgeland Sectional standings. Fourth-seeded **Cadott** is making its sixth appearance in the team tournament and its first since 2007 when they tied for the Division 3 championship. The Hornets also won the championship in 2001 and finished runner-up in 2005. They continue their quest for a third title after winning the St. Croix Falls Sectional.

State Tournament Scoring

DUAL MEET SCORING

All matches are six minutes in length.

The first period in all matches is started with both wrestlers in a neutral position on their feet. The second and third periods start from either the neutral position or referee's position down on the mat. The position is selected by one wrestler for the start of the second period and by his opponent for the start of the third period. Prior to assuming an offensive starting position, the offensive wrestler may signal to the referee the neutral position. The defensive wrestler is awarded an escape, and the wrestling begins from the neutral position.

When the wrestlers are on their feet, they are to work continuously for a takedown.

When a wrestler has the advantage, he must try to breakdown or flatten his opponent to set him up for a pinning combination.

Fall.....	6 pts.
Forfeit	6 pts.
Default.....	6 pts.
Disqualification	6 pts.
Technical Fall	5 pts.
Major Decision	4 pts.
Decision.....	3 pts.

Each wrestler in the tournament will wear a red or green ankle band for purposes of identification during the match. If, for example, a wrestler is wearing a green band and he scores a point in the match, the referee will indicate the point by calling out: "One point green." He will simultaneously raise the arm with the corresponding colored wristband and indicate the number of points with his fingers.

Fall or Pin – A fall is scored when a wrestler holds his opponent's shoulders to the mat continuously for two seconds. A fall ends the match.

Technical Fall – A technical fall is earned at any time a wrestler has gained a 15 point advantage over his opponent.

Decision – If neither wrestler scores a fall or technical fall, a decision is awarded to the wrestler who amasses the greater number of individual match points. If a match is tied at the end of regulation, the following overtime procedure will be used as outlined in the National Federation Rule Book:

OVERTIME PROCEDURES

When the contestants are tied at the end of the three regular periods, they will wrestle overtime. Overtime will consist of a one-minute sudden victory period, and if needed two 30-second tiebreakers. If the score remains tied at the end of the two 30-second tiebreakers, a 30-second ultimate tiebreaker shall take place. The procedure will be:

- a. no rest between the regulation match and the sudden victory;
- b. wrestlers in the neutral position;
- c. the wrestler who scores the first point(s) will be declared the winner; if no winner is declared by the end of the sudden victory, then the following procedure will be used:
 1. two 30-second tiebreakers will be wrestled to completion and score kept as in the regular match;
 2. the referee shall flip a disk to determine which wrestler has the choice of starting position for the first tiebreaker;
 3. the wrestler who has choice in the first tiebreaker may select top, bottom, or defer the choice to the opponent;
 4. at the conclusion of the first 30-second tiebreaker, the opponent will have the choice of top or bottom position;
 5. whichever wrestler has scored the most points in the two 30-second tiebreakers will be declared the winner;
 6. if the score is tied at the end of the two 30-second tiebreakers; the choice of position for the ultimate tiebreaker will be granted to the wrestler who scored the first point(s) in the regulation match (first three periods of the match); the wrestler whose opponent has received an unsportsmanship conduct penalty at any time during the match will have the choice of position. The unsportsmanlike conduct penalty will supersede the first points scored in the regulation match; if no points are scored in the regulation match, a flip of the disk shall determine the wrestler who has the choice (points for double-stalling or simultaneous penalties shall be considered as no points for the purpose of the tiebreaker choice);
 7. the wrestler who has choice may select top, bottom or defer the choice to the opponent;
 8. the wrestler who scores the first point(s) during the ultimate tiebreaker will be declared the winner. If no scoring occurs during the ultimate tiebreaker, the offensive wrestler will be declared the winner and the one match point shall be added to the offensive wrestler's score.
- d. a fall terminates the match.

Overtime is an extension of the regular match. All points, penalties, cautions, warnings, time-out and injury time will be cumulative throughout the regular match and the overtime period.

If the points earned in the sudden victory or ultimate tiebreaker involve a takedown or reversal straight to near-fall criteria, the match shall continue until the near-fall or fall situation has concluded.

TIES IN DUAL COMPETITION DURING STATE TEAM TOURNAMENTS

In the event there is a tie in dual competition during the sectional and State phases of competition, National Federation dual meet tie-breaking criteria shall be applied to determine a winner (NF Rule 9-2-2)

Note 1: If none of the listed criteria resolve the tie in quarterfinal and semifinal competition, an official will meet with captain of each team in center of mat and break tie by flipping colored disc with green representing home team and red representing visiting team.

Note 2: STATE Championship Finals: NF tie breaking criteria will be applied. If after all NF tie breaking criteria have been applied a tie remains unbroken - Co-Champions will be declared in lieu of flipping a colored disc.

INFRACTIONS

Stalling – Failing to wrestle aggressively. After one warning, the referee will penalize a wrestler for stalling by awarding his opponent one point.

Illegal Holds – Any hold which endangers the opponent or which is used for punishment only is illegal. The referee will award one point to the offended wrestler.

Technical Violations – Points will be awarded his opponent if a wrestler commits various technical violations such as: Delay of match, intentionally going off mat to avoid a situation, and clasping hand around opponent's body or legs while in a position of control down on the mat.

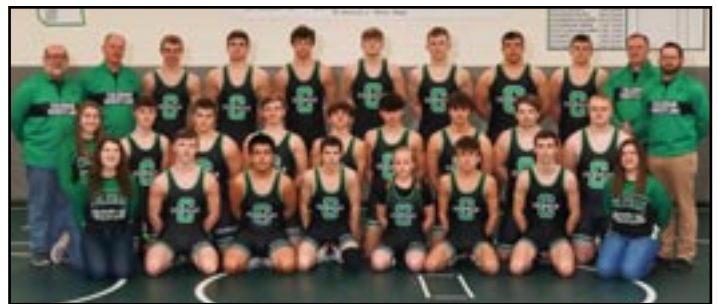
